Call for participants

First we'd like to take the opportunity to repeat our call for participants. We've held a number of interviews now and are extremely grateful to those who have already contributed their time, including our friends in Naples, Bologna, Berlin, Cologne and London. Our project flier is now available in [German](#), as well as in [Italian](#) and [English](#), so please pass it on to anyone who might like to take part. We are particularly keen to talk to asylum seekers or refugees claiming on the basis of sexual orientation or gender identity. We would also like to interview people who work with or support SOGI asylum seekers and refugees, including lawyers, service providers, judges and NGO staff. Interviews will be held on a strictly confidential basis and we will give potential interviewees full information about the research to help them make up their minds about whether to take part.

Recent and forthcoming SOGICA publications

- [Queering Brexit](#), by Carmelo Danisi, Moira Dustin and Nuno Ferreira, was published last month. Published on [The UK in a Changing Europe](#), the blog highlighted concerns about potential regression on LGBTIQ+ progress in the wake of the EU referendum, asking 'How little can Little Britain get?'
- [Case C-473/16, F v Bevándorlási és Menekültügyi Hivatal \(formerly Bevándorlási és Állampolgársági Hivatal\), Opinion of Advocate General Wahl, esd](#) was delivered on 5 October 2017. The case has worrying implications for the permissibility of psychological testing of LGBT asylum seekers. A blog piece on the case by Nuno Ferreira and Denise Venturi will shortly be published and will be posted on the SOGICA website and disseminated on Twitter and Facebook.

- Good news from the UK is that [Micro Rainbow International have opened the first housing specifically for LGBTI asylum seekers](#).
- It has been reported that [Karla Avelar, a transgender activist from El Salvador has sought refuge in Ireland](#). Karla left El Salvador because of concerns about her safety and that of her family. According to statements made by the director of sexual diversity for El Salvador's Secretary of Social Inclusion, approximately 600 LGBTI people have been killed in the country since 1993.
- Finally, UK Lesbian & Gay Immigration Group (UKLGIG) is [recruiting a part-time LGBTIQ+ Asylum Seeker Support Worker](#). The deadline for applications is 5.00pm Monday 27th November 2017.

Focusing on Germany, Italy and the UK as case studies, the project aims to determine how European asylum systems can treat asylum claims based on the claimant's SOGI more fairly.
