Call for participants

The SOGICA team is now in the middle of the fieldwork year of the project. We have carried out approximately 40 interviews with asylum seekers, refugees, lawyers, NGO representatives and decision makers in Germany, Italy and the UK, as well as observing two tribunal appeals. We are still looking for people who would like to participate in our project, and from across the breadth of the LGBTQI+ spectrum so that our research can better understand the diversity of experiences of asylum based on sexual orientation and gender identity. We are particularly keen to get in touch with LGBTQI+ asylum seekers and refugees who would like to take part in a focus group. We also wish to interview decision-makers and observe tribunal appeals in Germany, Italy and the UK.

To help us reach more people, the [project poster and information sheet are now available on our website in Arabic, Farsi, French, Turkish and Urdu](#) as well as the original versions in English, German and Italian.

Please get in touch if you would like to participate or know someone who would, and please help us get the message out by circulating [information about our project to your contacts](#). We give potential interviewees full information about the research, including important issues like confidentiality, to help them make up their minds about whether they would like to take part.

Recent and forthcoming publications

The SOGICA team have a number of articles and book chapters coming out over the next few months, all listed on the [SOGICA website publications page](#).

In January, Nuno Ferreira was interviewed on [Newshour – BBC World Service](#) (at minute 18:21) about a [CJEU judgment](#) regarding evidence standards in sexual orientation asylum cases.

The latest issue of the [Canadian Journal of Women and the Law](#) is a special issue on sexuality-based asylum claims to commemorate the work of Professor Nicole LaViolette. It includes a paper by Janna Wessels titled '[Publicly manifested – fatefully determined – invariably discreet. The assessment of sexuality-based asylum claims in Germany and France](#)'.
